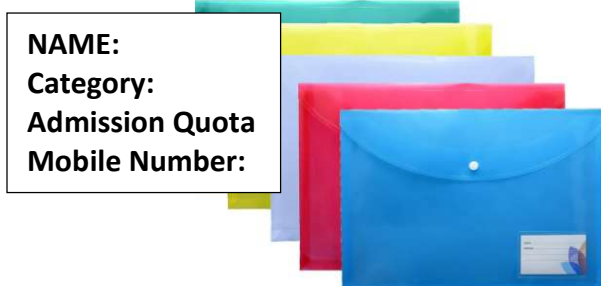
INSTRUCTIONS FOR MBBS ADMISSIONS PROCESS 2026-2027 **(All India Quota/ State Quota)**

All the selected students of NEET-UG-2026-27 at Govt. Medical College, AMRAVATI (Maharashtra) should follow the following instructions and report with all details required for admission.

Download & print this PDF file. READ CAREFULLY ALL DETAILS

1. Students should report personally for admission/ cancellation in case of upgradation. PROXY (anyone on behalf of student) will NOT be allowed for admission process/Cancellation of admission.
2. Print and fill out 2 copies of the Application Form.
3. Print and fill out 2 copies of the Holding Certificate.
4. Print and fill out 2 copies of the Candidate information.
5. Print and fill out 2 copies of the Admission Office Order.
6. Print and fill out 1 copy of Medical Fitness in the prescribed format ONLY.
7. Print and fill out 1 copy of the Declaration: Attendance, fees & restriction of campus activities.
8. Print and fill out in the 2 copies of All Declarations
9. All original documents enlisted in the holding certificate will be compulsorily required for admission.
10. Additionally, students should submit 2 Sets of SELF ATTESTED Xerox/photocopies of all original documents.
11. All original Documents INDIVIDUALLY SCANNED and in PDF format only will be compulsorily required during admission. Students should scan documents properly through computer scanner (Size 500 kb only). Please do not use a mobile scanner for scanning documents.
12. Individual Original Documents should be scanned and renamed appropriately. e.g. SSC/10th certificate after scanning should be renamed as SSC Certificate & Name of Student.
13. Prepare single Folder in pen drive and rename it with Name of the student, keep all scan documents in this folder for submission during admission. Name all the Scan documents (e.g. Caste certificate scanned pdf. file should be named as caste certificate). All scanned documents will only be accepted in Pen Drive. (**2 Pen Drive- 1 for College & 1 for self**)
14. Fees will be accepted by Demand draft (DD) during admission process. Kindly note that **DD should NOT have any errors/spelling mistakes in the name of DD. Error/spelling will not be acceptable, such DD will be rejected.**
15. **No cash/online transactions will be acceptable.**
16. Other Letters/undertakings if required will be taken at the time of admission if permissible within the rules thereof. This does not mean that any undertakings brought by the candidate will be acceptable.
17. Submit Recent Passport size photos (5 copies) with name on back side.

Further it is informed that for admission to B.Sc. Nursing course, the following criteria may be incorporated:

1. The minimum age for admission shall be 17 years and the maximum age limit shall be 25 years as on 31st December 2026.
2. Female and Male Ratio in admission – Female 80% and Male 20% students.
3. Admission of foreign national candidates in B.Sc Nursing under supernumerary quota from the upcoming session, as per INC approval, 5(five) seats under reservation for Foreign Students. (copy enclosed).

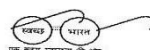

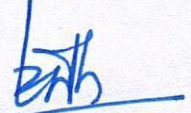

The candidates who have passed 10+2 level with Biology as an additional subject will also be eligible for MBBS Entrance Examination (as per Hon'ble Delhi High Court Order No.2341/-W/DHC/WRITS/D-1/2019 dated 24/09/2019 in the Writ Petition (C) No. 6773/2019) - Candidates who have appeared or are appearing at the qualifying Examination with English, Physics, Chemistry and Biology as main subject and expect to pass the Examination with required percentage of marks (as indicated in Sl. No. 03 below) are also eligible to apply and appear in the Competitive Entrance Examination. However, their candidature will be considered only if they provide documentary evidence of having passed the qualifying Examination with the required subjects and percentage of marks - If the institute has to consider an examination of an Indian university or of a foreign/university to be equivalent to the 12th class under 10+2 scheme/intermediate science examination, the candidates shall have to produce a certificate from the concerned Indian university/Association of Indian Universities to the effect that the examination passed by him/her is considered to be equivalent to the 12th class under 10+2 scheme/intermediate science examination. Eligibility Criteria for Puducherry UT Domicile Category Seats

A candidate is considered to be a domicile of the Union Territory of Puducherry if he/she satisfies at least one of the following criteria:

1. Candidates or their parents (either mother or father or both), or their guardian (in the case of children who have lost both parents), have been residing continuously in the Union Territory of Puducherry for at least five years immediately preceding the closing date of the NTA NEET application.
2. Candidates who have passed SSLC/HSC or any other public examination after undergoing academic studies continuously for five successive classes immediately preceding the qualifying examination (including the year of the qualifying examination) in recognised educational institutions located in the Union Territory of Puducherry and have resided in the Union Territory continuously for five years during that period.
3. Children whose parents are Central Government Servants, employees of Central Government Autonomous Institutions, State Government Servants, Defence Personnel, Central Paramilitary Forces, or employees of Public Sector Undertakings wholly or substantially run by the Central Government or the Government of Puducherry, who have been posted and serving in the Union Territory of Puducherry for at least three years immediately prior to the last date for submission of the application, provided the candidate has studied the Higher Secondary Course for two years in any school in the Union Territory of Puducherry and passed the Higher Secondary Examination from the same school.

4. Children of Defence Personnel who were killed or disabled in action and who have declared Puducherry as their hometown.

As per the verdict of Honourable Madras High Court in WMP. No. 20370 of 2020 in W.P. No. 16285 of 2020, the list of candidates who are eligible for seats under UT of Puducherry domicile category will be submitted by the Director, DHFWS-cum-Nodal Officer, (Medical Education), Directorate of Health and Family Welfare Services, Government of Puducherry to the Secretary, Medical Counselling Committee, Ministry of Health & Family Welfare, Government of India, New Delhi.
